IMPORTANT NOTES

Deadlines for submitting your license applications to the State Construction Licensing Board are due **60 days** before the date of the exam. Plumbing exams in the state of Georgia are administered by AMP. You must also register with AMP to be scheduled to take an exam, this registration is due **45 days** prior to the exam date. You must have a current Georgia Journeyman Plumbing license before you are eligible to take the Georgia Master Plumbing licensing exam.

In order to reserve a seat for a course, please return your completed registration form with payment to the PMA office ASAP. Students are accepted in the order applications with payments are received. This registration form for the course along with the course fee must be received no later to one (1) week prior to the scheduled class. Any course will be closed once it is full. Class size is limited. The course fee includes a non-refundable fee of \$100.00. Additional courses may be added to meet demand.

Cancellation Policy: You may cancel space in the course 72 hours prior to the first day of class; fees will be refunded less the \$100.00 non-refundable fee. Any cancellations less than 72 hours in advance will not be refunded. However, fees received after a class is filled, or cancelled due to insufficient registration will be refunded in full.
