These courses are scheduled to take place approximately two weeks prior to the license exam and are approved by the Georgia State Construction Licensing Board. Certificates will be given out at the end of class if you need to submit proof that you have attended a course.

IMPORTANT NOTES

Deadlines for submitting your license applications to the State Construction Licensing Board are due **12 weeks** before the date of the exam. Georgia plumbing exams are computerized and are administered by AMP. This means in addition to applying to the State License Board to be eligible to take an exam, you will need to submit an application to AMP to take the test. AMP applications are due **7 weeks** prior to the exam date. Please refer to above schedule of deadline dates*.

You must have a current Georgia Journeyman Plumbing license before you are eligible to take the Georgia Master Plumbing licensing exam.

In order to reserve a seat for a course, please return your completed registration form with payment to the PMA office ASAP. Students are accepted in the order applications with payments are received. Registration forms for the course along with the course fee must be received no later than one (1) week prior to the scheduled class. Any course will be closed once it is full. Class size is limited. The course fee includes a non-refundable fee of \$100.00. Additional courses may be added to meet demand.

Cancellation Policy: You may cancel space in the course 72 hours prior to the first day of class; fees will be refunded less the \$100.00 non-refundable fee. Any cancellations less than 72 hours in advance will not be refunded. However, fees received after a class is filled, or cancelled due to insufficient registration will be refunded in full.

You will need to bring to the course:

2006 International Plumbing Code (w/2007 - 2012 GA Amendments),
2006 International Fuel Gas Code (w/ 2007 -2012 GA Amendments),
Highlighter markers, paper, pens/pencils, and a calculator.
